Rationale	Tracking the number of ESKD patients in each of these treatment groups is important for quantifying the cost associated with dialysis and kidney transplants, as well as the need for kidney donations. Different patient outcomes and different costs are associated with each form of RRT.

Patients being treated in Prince Edward Island are included in the Nova Scotia count.  CORR is a longitudinal database, following patients over time. Reporting centres may submit changes/updates for any particular year on an ongoing basis. As a result, data is subject to change and may differ from data in previously published reports.
